## INTRODUCING OUR VOLUNTEER OF THE YEAR: KEITH JONES

In his quiet and understated way, Keith has shown his enthusiasm for our work through his deep appreciation for the beauty and bounty of our islands.

#### CHARTING A NEW COURSE

Lessons From Turtleback Shaping Our Future

IT HAS BEEN FIVE YEARS SINCE WE CONCLUDED OUR \$18.5 MILLION CAMPAIGN to protect Turtleback Mountain on Orcas Island. All of the stars aligned for us in 2006: a beloved property on a well-populated island, generous donors, an energized community, and a strong economy. While many of us will remember the Turtleback campaign among our most rewarding life experiences, we knew at the time that it would be difficult – if not impossible – to replicate that approach every time an important island property is under threat.

So we re-tooled. The first thing we did was to refine our conservation plan, which serves as our guide for prioritizing properties and choosing our projects. We then researched innovations in conservation finance, challenged our approach to land stewardship, confirmed our strategic direction and engaged in a national accreditation process that has put our policies and procedures to the test.

For a glimpse into the future of the San Juan Preservation Trust, you need to look no further than the results of this past year. The three projects described in this newsletter (on Vendovi, Blakely and Stuart islands), along with our recent conveyance of a saltwater beach parcel to Moran State Park (on Orcas), were identified as top priorities in our conservation plan and transacted during challenging economic times. Credit these successes to innovative financial tools, the determination of our board of trustees, staff, volunteers and advisors, and — as always — the remarkable generosity of islanders like you. As we move forward, we are resolved to remain focused on our priorities, mix patience with opportunism, and implement new approaches to conservation finance and stewardship. We will also continue to make the most of the resources that you provide to us: In the past year alone, we leveraged every membership dollar we received from you into \$15 worth of permanently conserved land.

The Campaign to Save Turtleback Mountain was indeed a turning point for the Preservation Trust. But as we reflect on the 5-year anniversary of that remarkable effort, it is interesting to consider that Turtleback's true value may have been in effecting a new and more replicable approach to conserving island land. If this past year is any indication – and we think it is – it appears that we are on the right track. As a partner in our progress, we hope that you will agree.

The Preservation Trust has permanently protected more than 260 properties, 34 miles of shoreline and 14,000 acres on 20 islands, including land now managed as public parks, nature preserves, wildlife habitat, and working farms and forests.

### PRESERVATION TRUST ACQUIRES VENDOVI ISLAND

The San Juan Preservation Trust has purchased Vendovi Island, the third largest island under single private ownership in the entire San Juan archipelago. With a purchase price of \$6.4 million, this is the second largest acquisition in the Preservation Trust's history. Funding came from anonymous private benefactors, including \$3.0 million in donations and a \$3.4 million bridge loan.


"We approached every potential conservation partner we could think of, but the price and terms seemed impossible to all of them," said Tim Seifert, the Preservation Trust's executive director. "Just as we had concluded that Vendovi was going to be out of our reach, these extraordinary new friends stepped in to offer their help." The Preservation Trust is seeking donors to help pay off the bridge loan.

Vendovi had been listed for sale at \$14.5 million before the owners attracted national media attention by holding an auction to sell the island. The Preservation Trust submitted the highest bid at that auction (\$3.3) million), but the sellers exercised their right to refuse



to sell at that price. Subsequent negotiations led to the \$6.4 million purchase price, which was close to half of its 2009 appraised market value.


At 217 acres with 2.8 miles of shoreline and six beaches, Vendovi is undeveloped but for one home site. Public access will likely be accommodated in the future once a natural inventory and management plan have been completed. ### ACRES ADDED TO NEIGHBORHOOD CONSERVATION EFFORT ON STUART ISLAND

The San Juan Preservation Trust is pleased to announce that a key 83-acre parcel has been added to a network of conserved lands on Stuart Island's iconic Tiptop Hill. With a donation of a conservation easement on their property, the Gund family has added their names to a list of generous and visionary neighbors that are permanently conserving the dramatic topography of this remote island near the U.S. - Canadian border. The Preservation Trust has been working with the Stuart Island community for several years to permanently protect Tiptop Hill and adjacent Reid Harbor. The Gund property, which spans the entire eastern flank of Tiptop, is blanketed with old growth forest and rare Garry oak savannah habitat. Visible from vantage points throughout the San Juan Islands and Canadian Gulf Islands, Tiptop is also adjacent to Stuart Island State Park in Reid Harbor, a popular recreational destination for boaters.


"It has been our intention to conserve this property



from the moment we purchased it," said George Gund. "We are thrilled to know that it will remain in its natural state

The Preservation Trust has assembled this network of conserved lands over many years through donations of land,

conservation easements and money from the Stuart Island community. This new conservation easement on the Gund property permanently prohibits any future development, protects important wildlife habitat, and represents a key milestone in this ongoing neighborhood effort.




### CROWLEY FAMILY ADDS TO BLAKELY ISLAND CONSERVATION NETWORK

Some things just take time. That was the case on Blakely Island when Lindy Springmeyer and Mike Kennedy contacted the San Juan Preservation Trust in 2004 seeking a conservation solution for their 80-acre Blakely Island property. Casting its shadow over Willow Island along the west coast of Blakely, this waterfront property is a familiar site along the Washington State ferry route between the Lopez and Anacortes terminals. With over half a mile of shoreline, Garry oak grasslands, patches of prickly pear cactus, and old growth forest (one of the few places left in the islands that has never been logged), this was clearly a jewel worthy of special attention.


Following months of negotiations, the project went dormant when we were unable to come to terms with Lindy and Mike. They reluctantly proceeded to put the property on the market.

Fast forward to the end of 2009, when Lindy and Mike's neighbors - Tom and Christine Crowley approached us with an innovative cost-sharing idea. Working closely with the Crowleys, the Preservation



Trust paid \$350,000 for the property – less than 25% of its appraised market value. The difference in value was donated to the project by the Crowley family.

This new "Crowley Preserve" will be maintained in its natural state in perpetuity. Including adjacent properties previously conserved by the Crowley family, the Preservation Trust now stewards 2,330 acres of conservation land on Blakely Island, which represents over one-half of this 4,435-acre island (the 5th largest island in San Juan County).


